New Laws to protect Personal Data-PDPA

La Cámara and MABC-Malaysian Australian Business Council will hold first Business Talk regarding to The **PDPA- Personal Data Protection Act 2010** which came into force on 15 November 2013 to remedy the mischief of unregulated misuse of personal data in Malaysia.

All "data users" will have 3 months from November 15, 2013 to register and comply with the Act.

The speaker for the event will be the **Commissioner** for the **Department of Personal Data Protection**, in Malaysia. We are ensured the relevant of that PDPA TALK for our members, cause this Act applies to any person who processes personal data in or in relation to a commercial transaction.

The Data Users lists the classes of data users who have to be registered with the Personal Data Protection Commissioner.

The sectors which have been specified are:

- Banking and Financial Institutions/ Communications / Direct Selling
- Education/ Health/ Insurance / Real Estate
- Services; Legal, Audit, Accountancy
- Tourism and Hospitality/ Transport
