- to promote, support and foster trade, services and investment between Malaysia and Spain.

## HOW TO BE A MEMBER OF “LA CÁMARA” ?

Membership of “La Cámara” is open to:

- Companies or firms (large, small and medium-sized companies, whether foreign or locally-owned or operated on a joint-venture basis, are eligible for membership) registered in Malaysia.
- Individuals residing or represented in Malaysia who are engaged in a business or a profession with special interests between Malaysia and Spain.
- Organisations who have an interest in the development of Malaysia and Spain relations.

There are three (3) principal classes of membership and they are:

- corporate,
- individual,
- affiliate members.

Only the corporate members may sit on the Executive Committee and vote at the general meetings.

Whether you are looking for a new partner, investment opportunities or reinforcement of your network in Malaysia, “La Cámara” will offer the networking environment to assist in your business development.

It is supported by the Economic and Commercial Office of the Embassy of Spain in Kuala Lumpur and in due time will seek official recognition as the official bilateral Chamber of Commerce & Industry in Malaysia with the Ministry of Industry, Tourism and Commerce of Spain.

## MEMBERSHIP

Membership subscription fee is payable on an annual basis that is from January 1st to December 31st. The following year's annual subscription fee shall be payable on or before January 31st of each year in advance. All annual subscription fee will be pro-rated for new members who join and divided in twelve (12) month period, and shall be payable on the day of admission to “La Cámara”. Membership is automatically renewed on an annual basis. Should you wish to discontinue your membership, please notify us in writing at least three (3) months before the end of the calendar year. The entrance fee is RM 200 for all types of memberships since 2019. “La Cámara” members are automatically members of the EU-Malaysia Chamber of Commerce and Industry (Eurocham) and your company profile will also be included in the EU-Malaysia Business Directory published by Eurocham.
